shall protect all persons suffering any loss or damage occasioned by said Principal failing to comply with any of the provisions of Chapter 89D of the North Carolina General Statutes or rules adopted there under, with respect to work performed by said Principal or officer, employee or agent of said Principal, or under the direction and supervision of said Principal and shall, without additional cost to the person for whom any such work is performed, remedy all defects in said work caused by a violation of Chapter 89D of the North Carolina General Statutes, or rules adopted there under, within one (1) year after the performance of any such work by said Principal, his agents or employees, and within forty-eight (48) hours after notice from the North Carolina Landscape Contractors' Licensing Board, then this obligation shall become null and void; otherwise to remain in full force and effect. The failure or default on the part of the Principal in remedying any defects in such work within 30 days after notice shall give the person for whom such work is performed a right of action against the Principal and Surety under this obligation; provided, however, that no suit, action, or proceeding by reason of any default shall be brought on this bond after one (1) year from date of final completion of the work done by the Principal for any such person.  This bond shall be considered continuous until such time as notification of cancellation is furnished to the North Carolina Landscape Contractors' Licensing Board.
