FOCUS ON: License Renewal

NCLCLB has sent renewal forms and reminders by mail and email. If you have not renewed yet, please renew now to avoid any delay in getting your renewed license and to avoid late/reinstatement fees.

Here are the answers to frequently asked questions to help you complete and return your renewal on time.

When does my license expire?

2016-2017 individual and corporate landscape contractor licenses expire July 31, 2017.

When are my renewal forms and payment due?

2016-2017 license renewal applications and payments must be postmarked, or submitted online, on or before August 1, 2017 to avoid reinstatement and late fees.

- IMPORTANT! the individual license renewal of the person (licensee) connected to the business must be submitted first.
- Annual Report Needed: To obtain a copy of your annual report, go to
 https://www.sosnc.gov/corporations/
 and select "Search by Corporate Name."
 Save the annual report on your computer so you can upload it when prompted by the online renewal form.

How much continuing education do I need to renew my license?

All licensed landscape contractors must complete seven (7) hours of Board Approved Continuing Education between August 1 and July 31 each year.

At least three (3) of the seven CEUs must be technical (landscape) credits and at least two (2) of the seven CEUs must be business credits. The remainder two hours can be either technical or business credit.

How do I prove I completed my continuing education?

You will be instructed to submit continuing education verification on your renewal application. Do not submit your proof of attendance forms; keep them on file at your office for two years following the renewal date for which they apply.

What do I do if I don't have enough continuing education?

Do I still need a surety bond?

Yes. Your \$10,000 NC Landscape Contractor Surety Compliance Bond or Irrevocable Letter of Credit must remain continuously in force. You do not need to submit your bond with the renewal application because the Board has already received your bond with your original license application. However, if any changes are made to your bond or letter of credit, send the original, signed and sealed document to our office within 30 days of the change.

A Look Into the Law - Landscape vs. General Contractor

Licensees should pay close attention to what they are agreeing to do when entering into contracts. While a licensed landscape contractor* is not required to have a general contractor's license for landscape projects of \$30,000 or more, per site, in a 12 month period, the landscape contractors' license does not permit a licensed landscape contractor to enter into contracts for projects that fall within the definition of general contracting.



Unless the services provided by a person, firm, corporation, etc. are considered to be <u>decorative utilitarian treatment</u> as defined in the NC Landscape Contractors' Licensing Law (N.C.G.S. §89D-11) a general contractor's license <u>would be required for the construction of any building, highway, public utilities, grading or any improvement or structure where the cost of the undertaking is \$30,000 or more.</u>

*Partial definition of "Landscape Contractor" (N.C.G.S.§89D-11 (3)): Any person who, for compensation or other consideration, does any of the following: a. Engages in the business requiring the art, experience, ability, knowledge, science, and skill to prepare contracts and bid for the performance of landscape services, including installing, planting, repairing, and managing gardens, lawns, shrubs, vines, trees, or other decorative vegetation, including the finish grading and preparation of plots and areas of land for decorative utilitarian treatment and arrangement.

Is Your Information Current?

According to State Statute 21 NCAC 28B .0204:

- (a) Every licensee shall keep the Board advised of the licensee's current mailing address, phone number, email address, and the name or names under which the licensee is practicing. If any change occurs, the licensee shall notify the Board in writing of the change within 60 days.
- (b) Upon the dissolution of a professional relationship, the member or members thereof shall notify the Board in writing concerning such dissolution and of the succeeding status and addresses of the individuals or firm.
- (c) Within 5 days after the lapse of a surety bond or revocation of a letter of credit prescribed in G.S. 89D-16(a)(4), a licensee shall notify the Board in writing. If a licensee fails to renew the surety bond or obtain a new letter of credit within 30 days after the lapse or revocation, the license shall be revoked.
- (d) Failure to notify the Board of the changes described in Paragraphs (a), (b), or (c) of this Rule shall constitute a violation of G.S. 89D-22.
