Instructions for Attaching Annual Report:

A copy of the business annual report can be printed by going to https://www.sosnc.gov/search/index/corp and then searching by corporate name. If the business entity is newly registered and an annual report has not been filed, attach the Articles of Organization. This requirement applies to business corporations, limited liability companies (LLCs) and other business entities required to register with the NC Secretary of State. Annual reports are not required for partnerships and sole proprietorships that are registered with the County Register of Deeds.

Corporate License Requirement (see G.S.89D-17 for full statute)

License may be issued in the name of a corporation, limited liability company, partnership, or business with an assumed or designated trade name if one or more officers, managers (as defined in G.S. 57D-1-03), executives, general partners, owners or full-time employees, empowered to act for the corporation, limited liability company, partnership, or business with an assumed or designated trade name, are individuals licensed under the NC General Statute § 89D, and are readily available to exercise supervision over the work performed pursuant to an executed contract for landscape construction or contracting in the name of the business.
