Focus On: License Renewal Use the NCLCLB Interactive Web Portal

Your license will expire on July 31, 2022.

You must complete your continuing education requirement by July 31, 2022 before you can renew, and Renewal Applications must be submitted online or postmarked on or before August 1, 2022 to avoid reinstatement and late fees.

If you haven't renewed your license yet, the NCLCLB Interactive Licensee Portal lets you renew immediately! It's quick and easy:

Click on the "RENEW ONLINE - PORTAL" button below.

Use your unique login id and password that was emailed to all licensed landscape contractors on Monday, June 22, 2022 at the email address on record. *Be sure to keep your username, password and security question answers in a safe place should you need them in the future.*

Fill out and submit the online renewal application.

Renewing on the NCLCLB Interactive Licensee Web Portal is quick, easy, and processes your renewal immediately for your peace of mind. However, you may still renew by mail by downloading the renewal form on the "Individual License Renewal" page of the Boards' website.

Did You Know?

Thinking of not renewing your license?

You could find that you could not recover your money if a client determines that you performed work while unlicensed in violation of the law.

While a court might rule otherwise, there is precedent in *Brady vs Fulgum* where a contractor filed against a homeowner to recover on a contract for construction of a home. The court ruled against the contractor saying the contract was unenforceable as it stemmed from an illegal contract because the contractor was unlicensed in violation of NC law.

Although there has not been a similar case involving a landscaper as yet, it is possible that should a similar situation occur, the court could issue a comparable ruling citing precedent that the landscaper was unlicensed in violation of NC law and therefore the contract or agreement was unenforceable.

Maintaining Your License

Minimum Standards

Remember, Minimum Standards are the law! They establish required guidelines licensed landscape contractors must follow on all landscape work - from contracts to installation.


