The North Carolina Landscape Contractors' Licensing Board's ("Plaintiff") Motion for Default Judgment was heard on September 29, 2025, before the undersigned presiding judge. The Court having reviewed the pleadings, makes the following:

FINDINGS OF FACT

- Plaintiff is an agency of the State of North Carolina created under the authority of Chapter
 89D of the General Statutes of North Carolina.
- 2. Defendant Uribes Landscaping, LLC ("Defendant") is:
 - a) A limited liability company organized in the State of North Carolina with a principal mailing address of 6521 Lincolnvile Rd. Raleigh, North Carolina. Ricardo Uribe is the Member for Defendant; and
 - b) Not presently and was not previously licensed by Plaintiff Board as a "Landscape Contractor," as that term is defined by N.C. Gen. Stat. § 89D-11(3).
- 3. By using the designation "Landscape Contractor" Defendant has violated N.C. Gen. Stat. § 89D-12.

4. Defendant has been duly served with the Summons and Complaint and Application for

Injunctive Relief in this action.

5. Entry of Default was filed on July 1, 2025.

CONCLUSIONS OF LAW

1. Plaintiff is authorized to bring this suit and to obtain injunctive relief under the provisions

of N.C. Gen. Stat. § 89D-24.

2. Defendant has violated N.C. Gen. Stat. §§ 89D-11 and 89D-12.

3. Plaintiff is entitled to judgment by default.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is hereby ORDERED,

ADJUDGED, AND DECREED that:

I. Plaintiff's Motion for Default Judgment is hereby granted;

II. Defendant is hereby permanently enjoined from advertising as a "landscape contractor" or

"licensed" until such time as Defendant is properly licensed by Plaintiff Board; and

III. Defendant is hereby permanently enjoined from the practice of landscape construction or

contracting in North Carolina until such time as Defendant is licensed by Plaintiff Board.
